



## Why The SmartCards On Genuine And Demonic Clergy, Scholars And Religions?

Over the Fall and Winter of 2006-2007, SmartCards were produced to depict the differences between [genuine and demonic clergy and scholars](#) and [genuine and demonic religions](#).

The SmartCard is a handy literary form used by United States Armed Forces to help military personnel to learn about and recognize facets and goings on in situations where they work, including combat operations.

With a view to helping our United States Armed Forces, especially those participating in Operations Enduring Freedom and Iraqi Freedom, the SmartCards linked above were developed.

Question was raised whether they really help in a combat situation, whether there is use for them in Iraq and Afghanistan and generally wherever United States Armed Forces are deployed.

Here is my answer:

The SmartCards help our military personnel and are useful in combat operations. Direct and anecdotal evidence has come to my attention supporting that evaluation.

One side benefit, as reported from a company in Iraq, is that African American Soldiers (apparently, many of them), seeing the SmartCard on demonic clergy and scholars, laughed out loud in recognition and said the right side of that SmartCard detailed exactly why they left the "Black Churches." They were grateful to have their reading of the demonic clergy of their experience confirmed. <sup>1</sup>

The primary benefit report was that some company and field grade officers found the SmartCard on clergy and scholars useful in dealing with "Muslim clerics" in Iraq.

The underlying reality is that our society is hog-tied by its resolute ignorance of two facts:

- that religion powerfully determines cultural and moral development;
- that there are genuine and demonic clergy and scholars and genuine and demonic religions whose presence is psycho-social pathology;

- ☑ given those two conditions any charlatan can claim to be clergy or scholar or religion and receive a pass on their agenda and activities based on their claim as well as a pass from the IRS on their money gathering and laundering.

This ignorance is alleged to be justified on the extra-Constitutional grounds of Mr. Jefferson's demagogic phrase, "wall of separation" between church and state. Actually, evoking that phrase -- which is extra-Constitutional -- to justify this ignorance is sneering contempt by members of one or both of these groups:

- \* demonic clergy posing as Christian and wishing to shield immoral and/or illegal activities from scrutiny and prosecution;
- \* Haters -- including demonic clergy claiming to represent other religions -- of Christianity and/or religion *per se*.

The phrase is taken to mean that, except in cases of that which is currently unacceptable (a politically mutable category), government entities may not evaluate claims of clergy and scholars or claims of religion. This is the effective outcome of Jefferson's phrase, an outcome he did not intend for it. <sup>2</sup>

There are philosophical reasons our society allows this to happen, which I will not go into more than to say that they are bad philosophy and comprise, for that reason, a huge hole in our national security. I have been looking at this hole for years and wondering how to address it. No one in

our leadership cadre that I have seen sees it, including our President and his entourage, despite the hole's huge presentment.<sup>3</sup>

It is what allowed the demonic Saudi clergy and scholars to get through on 11 September 2001. It is allowing them through again and again until the hole is closed by our leadership cadre's recognition that there are objective, observable behaviors and effects that mark off genuine clergy and scholars from demonic ones and genuine religions from demonic ones.

The need is a restoration of sanity by restoring reality to the construction of the non-establishment and free expression clauses of the First Amendment and the equal protection clause of the Fourteenth Amendment. The non-establishment, free expression and equal protection clauses are sane concepts radically different from Jefferson's "wall of separation" and especially the construction of that phrase by haters of Christianity and the United States.

Had the female official at the flight school Ata tried to enter in Florida, and the FBI and the CIA in their own ways, been aware of the signs of demonic clergy, scholars and religion, the attacks of 11 September 2001 probably would have been recognized and foiled. For her, the misogyny, the disdain for women, should have been enough to identify to her who it was talking to her.

The 911 experience proved that the usual screens on potential/actual anti-Americans and their plans are not enough because they overlook (for tendentious philosophical reasons) the actual nature, motivation,

goals and activities of persons, and most dangerously those bent on destruction of national sovereignty. <sup>4</sup>

These SmartCards represent a sub-field of Geography named [Theological Geography](#). They offer our Soldiers a check list of behavioral/consequential signs by which to evaluate the claims of individuals and groups with whom they deal. The SmartCards can help our Soldiers know even before they are shot at that they are dealing with a friend or an enemy. That is a significant assist in this era of "multicultural" demagoguery -- originating in academic faculties and their students -- that threatens all nations as surely as any tyrannical, inquisitorial ideology every has, including that of demonic clergy and scholars calling themselves Muslims.

Westerners and others, including Arabs, note from long experience how prone to lying, cheating and stealing Arabs are and Muslims generally, Arab or not. Muslims lie to everyone, including to one another. One of their doctrines legitimates the practice, especially for Shiites but also for Sunnis. The doctrine, called [dissimulation](#) or [taqiyya](#) in Arabic, commends lies and deceit if they further the aims of Muslim individuals or groups or the prestige of Islam.

These SmartCards offer behavioral signs for our Soldiers to recognize before shots come at them from the followers of demonic clergy and scholars who have just lied to and tried to deceive them. Most importantly, the check lists are universal. They can be used in any situation, any culture, any religious or academic context, to discriminate between genuine and demonic practitioners.

A grave, potentially lethal mistake is to say, as a General Officer did some years ago, that the battle is between Christianity as truth and Islam as

falsehood. An equally grave, potentially lethal mistake is to say, as academic faculties and their students do, that the battle is a "clash of cultures."

The ascription of validity to one religion and invalidity to another cannot be sustained because the evidence of plenary spiritual fulfillment and historical relevance (literally "raising up") in numerous religions, including especially Hinduism, Buddhism, Zoroastrianism, Islam, and Christianity, cannot be ignored or dismissed.

Likewise, the assertion of "culture war" implies that the protagonists, genuine religion and culture and demonic religion and culture, have equal claims -- the view of reductionist humanism -- and therefore equal validity. Reductionist humanism asserts the impossibility of evaluation on any basis other than current custom and power differentials, which are mutable. But this assertion falsifies itself by a presumption of its own accuracy, a presumption that acts as a logical and experimental absolute and therefore as an immutable basis for evaluation.

The battle is neither seen, described nor understood by either of those views, neither by the protagonists of a demonic Christianity (so-called "evangelicalism" or "fundamentalism-literalism") nor by the protagonists of reductionist humanism (which is preached by academic faculties and their myrmidons).

The battle is between culture, religion and morality on the one hand, and demonic clergy, scholars and religion embodying anti-culture, anti-religion and anti-morality on the other hand. Demonic clergy, scholars and religion are found in Hinduism, Buddhism, Zoroastrianism, Islam and Christianity but they neither speak for nor represent those religions.

No religion fights another, no culture fights another and no morality fights another. Nor does any culture fight religion, any religion fight culture, any morality fight religion or culture, etc. Demonic religion, culture and morality fight the genuine representatives of all three functions of

spirit. There has never been a religion war or a culture war or a war between competing moralities. There never will be because religion is religion, culture is culture and morality is morality and none has a second.

There have been many wars between cultures generated by religions on the one hand and demonic religions and/or cultures on the other hand. In those wars, religions and cultures always are in a defensive posture -- and always ultimately successful -- relative to demonic religions and cultures, which by nature embody an offensive posture. <sup>5</sup>

The natural estate of religions, cultures and moralities is peace. Any disturbance of their peace is caused by offensive action from demonic religions, cultures and/or moralities.
